The purchaser consents that any information related to the purchaser's participation in the program, purchase of the Measure or use of the Measure may be shared with SDG&E, any IOU and the CPUC. • A disclaimer of any responsibility of any IOU in connection with the selection, purchase, ownership and use of program Measures, and a release and indemnification of SDG&E and all IOUs from and against any claims, suits, proceedings, losses, liabilities, damages, costs, expenses, and fines arising from the purchase, ownership, installation, use, alteration, repair, replacement, or maintenance of any program Measure; and • The purchaser will not receive any discounts, incentives, or incentives from another governmental, utility, public agency, or IOU program funded in whole or in part by IOU Customers for the same program Measures.
