- **Non-CFC Foam Insulation**—Covers the sides and top of tank, reducing the amount of heat loss. This results in less energy consumption, improved operation efficiencies, and jacket rigidity.
- **Pedestal Base**—Rugged and durable base allows easy transport and positioning and corrosion-resistant contact with floor.
- **Water Connections**—3/4" NPT factory-installed true dielectric fittings extend water heater life and ease installation.

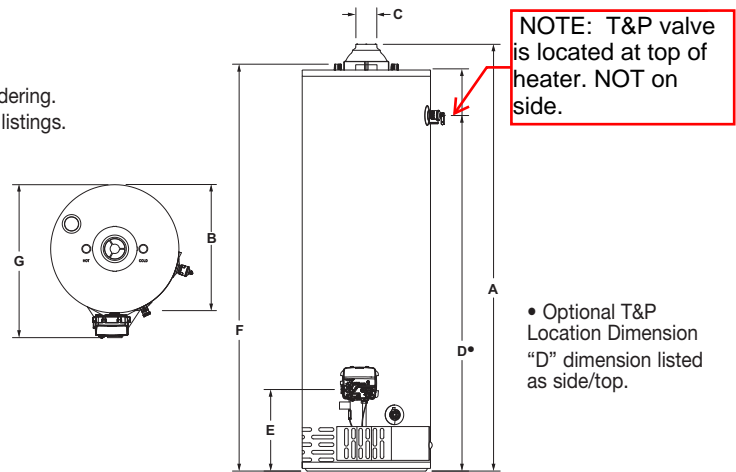
